Girardin - Chromebook Agreement

General Information

Student use of a school-issued Chromebook falls under the scope of Oldham County High School's Acceptable Use Policy and Agreement for Technology. All rules and regulations as stated in said agreement must be followed. All applications, activities, documents, extensions stored on the Chromebooks, or through GAFE accounts, are the property of Oldham County Schools and subject to regular review and monitoring.

In addition to the rules and regulations set forth in the OCHS Acceptable Use Policy and Agreement for Technology, students must also adhere to the guidelines set forth in this agreement.

General Usage

Students will not modify the Chromebook in any way other than instructed by school personnel.

Students will not exchange Chromebooks with another student unless instructed to do so. Students must ONLY use the Chromebook that is assigned to them.

Students will not remove the Chromebooks from the designated area.

No permanent marks, decorations or modifications should be made to the Chromebook or the cover.

Students may not clear or disable the browsing history, use a private browser, nor may they set a general password on the device.

Altering the administrative settings on the Chromebook is forbidden. Student must ONLY use the Chromebooks for activities that are school and class appropriate to the instructional goals of the class.

Absolutely no pictures or videos will be taken nor posted unless instructed to do so by the instructor for the purpose of instructional or assessment activities.

Internet Usage

Acceptable Use – Internet usage during school is for research, education and to provide a platform for collaborative projects. The use of the Internet by the student must be in accordance with OCHS Acceptable Use Policy and Agreement for Technology. Use of other organization's networks or computing resources must comply with the rules appropriate for that network as well. Transmission of any materials in violation of any national or state regulation is prohibited. This includes, but is not limited to: copyrighted material, threatening or obscene material, or material protected by trade secret.

Etiquette-Students are expected to abide by generally accepted rules of network etiquette. This includes (but is not limited to) the following guidelines:

Be polite. Absolutely no abusive, rude, or offensive behavior or language.

Illegal activities are strictly forbidden.

Never reveal any personal information (such as address, phone number, image, etc.) of yourself, another student or school personnel.

Respect network usage so that others may also benefit from its use.

All communications and information accessible via the network (including e-mail) should be assumed to be publicly accessed by all Oldham County Staff.

Applications & Extensions

Certain apps and extensions deemed to be relevant to the course, by course instructors and administrators at Oldham County High School, will be added to the student's GAFE account in class. GAFE accounts are property of Oldham County Schools an as such are subject to search at any time.

Access to Materials

Chromebooks operate on a cloudbased storage system. All documents, book marks, apps, extensions, resources, etc are accessible on ANY device with an internet connection.



Damage

Damage due to a determined accidental cause will be addressed by the school through normal procedures. Damage due to negligence or malicious behavior, such as vandalism, may result in the student and/or parent assuming the financial responsibility of the repair or replacement of the Chromebook.

Student Responsibilities

- Any error or problem with the Chromebook should be reported to the instructor or school personal as soon as possible. This will allow school personnel to address the issue as well as prevent confusion if the malfunction is deemed to be due to malicious user behavior
- Each student must ensure he/she is logged on to HIS/ HER own account.
- Students MUST log out at the end of class.
- DO NOT touch the screen.
- Make sure hands are clean prior to handling the Chromebook.
- Keep Chromebooks away from food and drink.
- Ensure the Chromebook is properly stowed after use.

Failure to abide by the rules set forth above or the regulations as stipulated in the Oldham County High School Acceptable Use Policy and Agreement for Technology may result in cancellation or suspension of privileges, school disciplinary action and/or possible legal action or financial responsibilities.
